

JOINING INSTRUCTIONS B.Sc. (FAD) & B.Sc. (IDD)

1. **Course Duration.** The normal duration of the course is three years (six semesters). The Course is affiliated to Bengaluru North University. Classes starts from 01 Aug 2022. As per the NEP 2020, the optional duration can be 4 Years (8 Semesters).

2. **Date of Reporting for Admission and Action to be Taken.** You are required to report to the Principal/Registrar of this Institute **on 01st Aug 2022** along with the following **certificates in original** and two sets of photocopy (**10th Std, 11th Std & 12th Std Passing Marks Cards, TC, Character & Migration Certificate**) ie. one set of photocopy to be handed over to the office and one set of photocopy to be retained with the student during the whole course. Originals will be submitted to the college for verification along with one set of photocopies. Photocopy to be done from home station itself as Institute will not provide photocopies while joining the Institute.

Also **Submit the hard copy of Admission Application Form duly signed by the Student, Parent / Guardian alongwith uploaded attachments in original.**

5. **Hostel Accommodation and Messing Charges per Annum.** Accommodation will be made available on Campus for boys and girls separately. Fee payment can be made through RTGS/NEFT / Any pay (Google Pay / Phone pe etc) for Hostel Accommodation for Rs.49,175/- (less advance Rs 5,000/- paid in advance as Hostel Registration fee) and Messing charges Rs 50,400/- (subject to changes depending on new contract) for ten months ie. less two months semester vacation period to be **paid on or before 30 Jul 2022**. All first year Army wards will stay compulsorily in the Campus Hostel.

6. **Inability to Report on Due Date for the Course.** In case due to unavoidable circumstances, you are not in a position to report to this Institute on 01 Aug 2022, your parent/guardian/representative should report to this Institute with necessary documents/certificates and take all decisions pertaining to admission. Performa for letter of authority is attached as **Appendix 'A'** to the instructions. If you or your parent/ guardian/representative do not report to this Institute on the due date, your candidature will be cancelled and no representation will be entertained in this regard. Requests for extension of joining date will not be accepted under any circumstances/reasons whatsoever. However, the candidates, who are deputing their parents/guardians/representatives are required to report to this Institute latest by 08 Aug 2022 and the candidate should report to the Institute latest in the third week of Aug 2022 without fail.

7. **Discipline.** You are expected to conduct yourself strictly as per norms and code of conduct of this Institution. In case you are found lacking in discipline or fail to abide by the rules and regulations of the Institute, action will be taken as per the AWES Rules.

8. **Clothing.** Bangalore has moderate climate round the year. You are, therefore, not required to bring heavy winter clothing. However students staying in the hostel are required to bring the following items :-

Note 1 :- Students will be provided with Steel Almirah, Table, Chair, Single Cot with Mattress & Pillow. Other minor items can be procured from the local market as per the requirement of the student.

Note 2 :- **Dress Code and Mobile** : Institute will provide uniform to the students. All students are required to wear institute uniform everyday from Monday to Saturday except Thursday. Blazer with uniform will be worn on Wednesday. No slippers/sandals permitted in class rooms/offices/college premises. Details of the other dress code will be provided during admission.

9. **Valuables.** You are advised not to bring jewellery or other valuable items along with you. Use of mobile phone inside the Campus is restricted.

10. **Amount for Immediate Personal Expenditure.** It will be the responsibility of the students to keep their cash in Bank. The students are, therefore, advised not to bring large sums of money except in the form of bank drafts.

11. **Banking Facilities.** There are more than three nationalized banks available within three KMs radius from the institute. Students can open their new Bank Account in their own interest. However, the parents are advised to open Bank Account in the name of their ward preferably in their home town which students can operate through ATM.

12. **Local Guardian.** The students who are admitted to Hostels will be allowed to visit only their local guardian residing in Bangalore during weekends/gazetted holidays as per rules. For this purpose, you are required to bring a letter of consent in duplicate, duly signed by your parent /guardian giving address of the local guardian. You may note that only one local guardian is permitted. The Performa to be completed in duplicate by the parent of the students is given in **Appendix 'B'** attached. The Performa should be completed and handed over to the Institute on the day of joining.

13. **Boarding and Lodging Arrangement Till Admitted to the Institute / Hostel.** You are advised to make your own arrangements for yourself and your parents/guardian on arrival at Bangalore till you are finally admitted to the Institute/Hostel. 14. **Acknowledgement.** You are required to confirm your acceptance of this offer. The confirmation should be sent by e-mail to the Principal, Army Institute of Fashion and Design within ten days of receipt of this Joining Instructions.

15. Please note that the admission to this Institute is provisional, subject to your fulfilling the eligibility conditions for admission as approved by Bengaluru North University.

16. **Ragging.** Instructions received from AWES, AG's Branch, New Delhi vide their letter No B/45728/WAT/AWES dated 06 Apr 2009. The instructions regarding ragging are as follows :-

(a) Ragging is banned in educational institutions and hostel as per Hon'ble Supreme Court orders. Anyone indulging in such acts shall be subjected to punishment by a Court of Law/concerned authorities.

(b) "Ragging means causing, inducing, compelling or forcing a student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity or violates his persons or exposes him to ridicule or to for bear from doing any lawful act, by intimidating, wrongfully restraining, wrongfully confining or injuring him or by using criminal force on him or by holding out to him any threat of such intimidation, wrongful restraint, wrongful confinement, injuring or the use of criminal force".

RULES AND DISCIPLINE FOR ADMISSION IN HOSTEL :-

- 1) Admission is open to full time students of AIFD.
- 2) The application form completed in all respects should be submitted to the Office of the AIFD on any working day during office hours.
- 3) Admission to the Hostel will be cancelled if incomplete or false information is furnished.
- 4) Students will be required to vacate the room within 5 days on completion of the scheduled examination each semester.
- 5) Students are allowed to stay in the Hostel during the Winter / Summer vacations only for internship.
- 6) Hostel fee for the next academic year is required to be paid in the month of February to April.
- 7) AIFD reserves its right to cancel admission of undeserving students without giving any reason.
- 8) AIFD reserves its right to increase the hostel fee, if necessary.
- 9) AIFD will not be responsible for any mishap.
- 10) Student residing in the Hostel managed by AIFD shall strictly observe all the Rules and Regulations in force from time to time. Breach of rules / regulations may invite rustication / fine.
- 11) During their stay in the Hostel they will be under the control of the Officials of AIFD.
- 12) Smoking, consumption of alcoholic drinks and spitting is strictly prohibited in the hostel premises.
- 13) No guest or visitor of the inmate will be permitted to visit rooms. Visitors and guests should be received in the Visitors room or Reception area only between 9.00 AM to 6.00 PM.
- 14) Every student shall be in his / her hostel by 9.00 PM. If he / she has to stay out after the said timing owing to any special reason, he / she must obtain prior permission from the Registrar. The application for leave of absence from the hostel shall be made in writing thru HOD/Mentor to the Principal and Registrar and his/her permission shall be obtained. Late entry without prior permission will invite penalty / rustication.
- 15) No students shall use the service of a hostel servant for personal work even on payment. He/she shall also not bring any servant from outside even temporarily.
- 16) Students will not enter rooms of other students without permission of the inmates. Students should not go to other students flat after 10.00 PM in the night.
- 17) Every case of illness and accident must be reported immediately to the Warden and Registrar.
- 18) No functions or celebrations shall be organized except with the permission of the Registrar.
- 19) Resident students are not permitted to convene any meeting of any sort under any circumstances anywhere in the Hostel premises without the prior permission of the Registrar or the Management.
- 20) No poster etc. should be put up anywhere, either in rooms or lobbies.

- 21) Students are not allowed to play any kind of sports in the room.
- 22) Throwing of water, colour etc. on one another and on the walls / property of the hostel is strictly prohibited.
- 23) Students suffering from any contagious disease will not be allowed to stay in the hostel. Decision of the Registrar in this regard will be final and binding.
- 24) Allotment of the room, furniture etc. will be entirely at the discretion of the Registrar / Warden and no complaint in this regard will be entertained.
- 25) Every student shall keep the room allotted to him clean and neat. He / She shall take proper care of the furniture and fixtures handed over to him / her. The hostel authorities have the right to enter and inspect the rooms at any time, even in the absence of students.
- 26) All matters relating to differences among students and complaints about the hostel servants shall be brought to the notice of the Registrar, who will take such action as may be necessary. No police complaint will be lodged by the students before taking prior permission from the Registrar.
- 27) Students are expected to switch off the lights and fans in their rooms every time they go out and take precautions to economise electricity consumption.
- 28) Charges for any damages to the property as well as to the furniture and fixtures caused by a student/students negligence will be recovered from the student/students staying in the said room.
- 29) Student should not drive nails, screws etc. into the wall or doors. No repair shall be done by the students themselves. They should approach the Registrar/Warden who will arrange for repairs.
- 30) Hostel is meant only for the use of bonafide students of that particular hostel. Visitors are not allowed to enter any room.
- 31) The Hostel Authorities do not hold themselves responsible for the safe custody of the property of the students staying in the hostel. Students should provide their own locks and should take proper care of their belongings. They should not leave the key of the room anywhere around. AIFD will not be responsible for the loss of personal belongings of the students.
- 32) All the facilities including additional facilities like Telephone, T.V., Magazines, News paper, Internet etc., if misused, shall be discontinued without given any notice and disciplinary action will be taken against the students involved.
- 33) Before leaving the hostel, a student must pay all dues and hand over the charges of rooms and other material in satisfactory condition to the Registrar.

39) Students are provided with some add on facilities (tentative) like TV / Washing Machine / Internet connection / Single bed /cot/ Almirah / Chair/Table etc. Cleaning staff / Security services are provided at every location. Since down time in the operation of internet is a general phenomena, hence students are expected to bear the same.

40) Refund of Hostel fee is allowed only in the case of cancellation of admission from AIFD. Refund is done as per AWES rules and regulations notified in Prospectus.

41) Ragging is completely prohibited in the Hostel. Student found involved in any type of ragging in the Hostel or campus, action will be initiated as per the Supreme Court directions. Action will be initiated within 24 hours of the incident. Parent and student should go through the Supreme Court direction of Ragging in the campus.
